

# Privacy Statement

**SkyNet Worldwide Express** is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the **SkyNet Worldwide Express** Website, CRM & electronic shipping system and governs data collection and usage. By using the **SkyNet Worldwide Express** website and electronic shipping system, you consent to the data practices described in this statement.

## Collection of your Personal Information

**SkyNet Worldwide Express** collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. **SkyNet Worldwide Express** also collects anonymous demographic information, which is not unique to you, such as your postcode, age, gender, preferences, interests and favourites.

There is also information about your computer hardware and software that is automatically collected by **SkyNet Worldwide Express**. This information can include: your IP address, browser type, domain names, access times and referring Website addresses. This information is used by **SkyNet Worldwide Express** for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the **SkyNet Worldwide Express** Web site and populates electronic shipping system.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through **SkyNet Worldwide Express** public message boards, this information may be collected and used by others. ## Use of your Personal Information

**SkyNet Worldwide Express** collects and uses your personal information to operate the **SkyNet Worldwide Express** Website CRM & electronic shipping system and deliver the services you have requested. **SkyNet Worldwide Express** also uses your personally identifiable information to inform you of other products or services available from **SkyNet Worldwide Express**.

**SkyNet Worldwide Express** may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

**SkyNet Worldwide Express** does not sell, rent or lease its customer lists to third parties. **SkyNet Worldwide Express** may share data with trusted partners for operational purposes and to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to **SkyNet Worldwide Express**, and they are required to maintain the confidentiality of your information.

**SkyNet Worldwide Express** does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

**SkyNet Worldwide Express** keeps track of the Web sites and pages our customers visit within **SkyNet Worldwide Express**, in order to determine what **SkyNet Worldwide Express** services are the most popular. This data is used to deliver customized content and advertising within **SkyNet Worldwide Express** to customers whose behaviour indicates that they are interested in a particular subject area.

**SkyNet Worldwide Express** Website will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on **SkyNet Worldwide Express** or the site; (b) protect and defend the rights or property of **SkyNet Worldwide Express**; and, (c) act under exigent circumstances to protect the personal safety of users of **SkyNet Worldwide Express**, or the public.

## Use of Cookies

The **SkyNet Worldwide Express** Web site use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize **SkyNet Worldwide Express** pages, or register with **SkyNet Worldwide Express** site or services, a cookie helps **SkyNet Worldwide Express** to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
